

Federation Speaks Out Against Proposed Rescission of CDFI Fund Appropriations

Federation President/CEO Cathie Mahon spoke out against proposed cuts to the CDFI Fund: "The rescission of funding for BEA and Capital Magnets will directly impact consumers in low-income communities served by CDFI certified credit unions. [...] The reduction of support for any of these CDFI Fund programs results in reductions in the access to credit, financial services, affordable housing and services and asset building strategies and supports in communities that need it most." Mark your calendars! The next intake rounds for qualifying low-income-designated credit unions to apply for streamlined CDFI certification with NCUA will be **June 4-22nd**, and then **September 10-28th**.
