### **CDFI Credit Union Impact**

Community Development Financial Institutions (CDFIs) must meet stringent criteria to become certified. CDFI credit unions must:


- Direct at least 60% of their lending toward economically distressed people and communities, and
- Build members' capacity to manage credit, increase savings, and increase their financial well-being.

### Maryland's 2 CDFI Credit Unions:

- Have combined assets of \$1.5 billion
- Serve 115,490 members through 13 branch locations

## Maryland's CDFI Credit Unions achieve impact through \$972.8 million in active loans to members, including:

- \$376.8 million in community mortgage lending
- \$349.0 million in local consumer financing
- \$130.1 million in lending to local businesses
- \$117.0 million in affordable small-dollar lending



#### In Maryland's CDFI Investment Areas:

- **13.0%** of residents have incomes below the federal poverty line
- The median family has an annual income of \$71,610
