CDFI Credit Union Impact

Community Development Financial Institutions (CDFIs) must meet stringent criteria to become certified. CDFI credit unions must:


- Direct at least 60% of their lending toward economically distressed people and communities, and
- Build members' capacity to manage credit, increase savings, and increase their financial well-being.

Pennsylvania's 2 CDFI Credit Unions:

- Have combined assets of \$815.5 million
- Serve 79,838 members through 13 branch locations

Pennsylvania's CDFI Credit Unions achieve impact through \$490.1 million in active loans to members, including:

- \$158.5 million in community mortgage lending
- \$236.6 million in local consumer financing
- \$58.1 million in lending to local businesses
- \$36.9 million in affordable small-dollar lending



In Pennsylvania's CDFI Investment Areas:

- 19.0% of residents have incomes below the federal poverty line
- The median family has an annual income of \$57,548
