



CDFI Credit Union Impact

Community Development Financial Institutions (CDFIs) must meet stringent criteria to become certified. CDFI credit unions must:

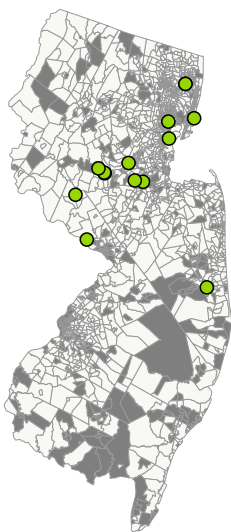
- Direct at least 60% of their lending toward economically distressed people and communities, and
- Build members' capacity to manage credit, increase savings, and increase their financial well-being.

New Jersey's 3 CDFI Credit Unions:

- Have combined assets of **\$648.9 million**
- Serve **35,542** members through **14** branch locations

New Jersey's CDFI Credit Unions achieve impact through **\$490.3 million** in active loans to members, including:

- **\$314.8 million** in community mortgage lending
- **\$34.5 million** in local consumer financing
- **\$107.4 million** in lending to local businesses
- **\$33.5 million** in affordable small-dollar lending

In New Jersey's CDFI Investment Areas:

- **16.0%** of residents have incomes below the federal poverty line
- The median family has an annual income of **\$65,206**
