Noel Andrés Poyo serves as **NALCAB's Executive Director and CEO** of NALCAB's subsidiary asset management company Escalera Community Investments. Poyo's twenty-year professional career has focused on integrating low-income people and immigrants into mainstream financial services and real estate sectors of our economy as well as improving the livability and economic resilience of low-income neighborhoods and affordable housing communities. Poyo advises the executive leadership of JPMC Bank, BBVA Compass Bank and Capital One Bank. He serves on the Board of Directors of the Center for Responsible Lending, the nation's

leading research and advocacy organization focused on combating predatory lending.

Martha Ninichuk serves the **Director of the Office of Credit Union Resources and Expansion at the NCUA**. In this role, Ms. Ninichuk is responsible for chartering and field-of-membership matters, low-income designations, charter conversions and bylaw amendments. Her office also provides online training to credit union board members, management and staff, and technical assistance through grants and loans funded by the Community Development Revolving Loan Fund. Additionally, Ms. Ninichuk oversees the agency's minority depository institutions preservation program.



Michelle Outlaw is the **Vice President of Programs for the African-American Credit Union Coalition (AACUC)**. Additionally, she currently consults with various organizations training clients on technological systems and operational platforms. Michelle was the President and CEO for First Legacy Community Credit Union, one of the last standing African-American credit unions in North Carolina until it was merged. She has over 30 years experience working with credit unions and banks. Michelle has a Bachelor of Science in accounting from North Carolina Agricultural and Technical State University, a Master of Accounting and Financial Management from Keller School of Management, and a Master of Divinity from Shaw University. She is also a current doctoral student at Trinity School for Ministry.



Monica Belz is **President and CEO of Kauai Government Employees Federal Credit Union**. Formerly, Monica was the Vice President of Strategic Development at Gather Federal Credit Union. Monica's experience in the credit union industry includes strategy development, branding, market entry, global development projects, marketing, and community development initiatives. Her background includes launching a company specialized in global projects for multi-national corporations, real-estate development and portfolio management, and international development work. She holds a Global MBA from Thunderbird School of Global Management and a BA in Communications from Vanguard University of Southern California.



Gisele Roget is **Deputy Chief of Staff at the NCUA** overseeing the Office of External Affairs and Communications and leading the agency's communications and congressional affairs initiatives. Roget previously served as Deputy Assistant Secretary for Single Family Housing at the Federal Housing Administration since 2017 managing a 750-person organization implementing the federal government's primary mortgage program for low- to moderate-income borrowers. Previously, Roget held senior roles in the Global Government Relations division of MetLife and also served on the professional staff on the Financial Services Committee in the U.S. House of Representatives.
