Targeted CDFI Support Services for Minority Depository Institutions

In 2021, an unprecedented level of external funding was dedicated to Community Development Financial Institutions (CDFIs) through the CDFI Fund and Treasury's Emergency Capital Investment Program.

Now, more than ever, CDFI certification is an essential credential for credit unions with a focus on financial inclusion and who need financial resources that can have a transformational impact on the credit unions and the communities in which they serve.

Inclusiv is the credit union industry's best resource for understanding the CDFI business model and its impact on local economies. The next round of CDFI funding (\$1.75 billion) will be targeted specifically to Minority Depository Institutions (MDIs). However, only 15% of minority-designated credit unions are CDFI certified. We have specific resources targeted to MDIs interested in becoming CDFI certified and accessing these federal grants.

CDFI Annual Certification Report (ACR)

Inclusiv prepares the CDFI annual certification report (ACR) for our members. ACR service includes detailed analytics such as: CDFI target market lending, lending in persistent poverty counties, lending in Opportunity Zones, and more.
