



## CDFI Credit Union Impact

Community Development Financial Institutions (CDFIs) must meet stringent criteria to become certified. CDFI credit unions must:

- Direct at least 60% of their lending toward economically distressed people and communities, and
- Build members' capacity to manage credit, increase savings, and increase their financial well-being.

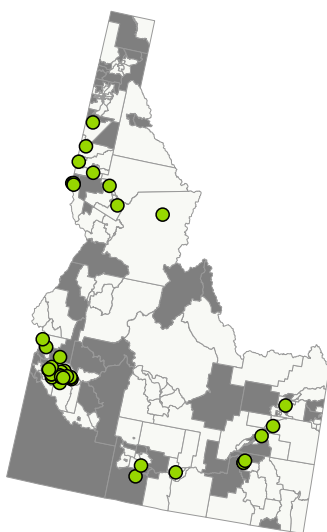
### Idaho's 6 CDFI Credit Unions:

- Have combined assets of **\$3.0 billion**
- Serve **184,510** members through **40** branch locations

---

### Idaho's CDFI Credit Unions achieve impact through **\$2.3 billion** in active loans to members, including:

- **\$897.8 million** in community mortgage lending
- **\$1.0 billion** in local consumer financing
- **\$309.4 million** in lending to local businesses
- **\$119.8 million** in affordable alternatives to predatory payday loans

### In Idaho's CDFI Investments Areas:

- **10.5%** of residents have incomes below the federal poverty line
- The median family has an annual income of **\$59,612**
