



CDFI Credit Union Impact

Community Development Financial Institutions (CDFIs) must meet stringent criteria to become certified. CDFI credit unions must:

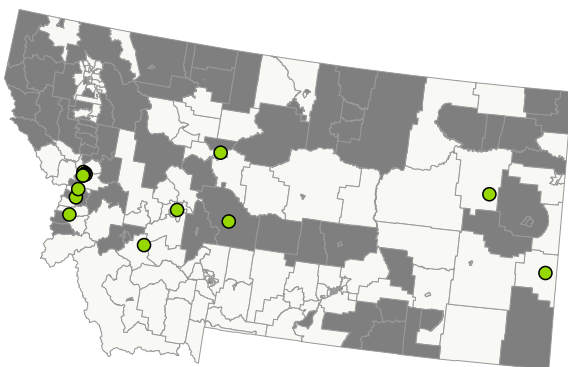
- Direct at least 60% of their lending toward economically distressed people and communities, and
- Build members' capacity to manage credit, increase savings, and increase their financial well-being.

Montana's 4 CDFI Credit Unions:

- Have combined assets of **\$1.2 billion**
- Serve **73,336** members through **15** branch locations

Montana's CDFI Credit Unions achieve impact through **\$852.7 million** in active loans to members, including:

- **\$386.7 million** in community mortgage lending
- **\$250.1 million** in local consumer financing
- **\$163.8 million** in lending to local businesses
- **\$52.1 million** in affordable small-dollar lending

In Montana's CDFI Investments Areas:

- **9.8%** of residents have incomes below the federal poverty line
- The median family has an annual income of **\$59,156**
