CDFI Credit Union Impact

Community Development Financial Institutions (CDFIs) must meet stringent criteria to become certified. CDFI credit unions must:

- Direct at least 60% of their lending toward economically distressed people and communities, and
- Build members' capacity to manage credit, increase savings, and increase their financial well-being.

New Jersey's 5 CDFI Credit Unions:

- Have combined assets of \$711.1 million
- Serve 39,452 members through 19 branch locations

New Jersey's CDFI Credit Unions achieve impact through \$521.7 million in active loans to members, including:

- \$350.6 million in community mortgage lending
- \$17.9 million in local consumer financing
- \$123.7 million in lending to local businesses
- \$29.4 million in affordable small-dollar lending



In New Jersey's CDFI Investment Areas:

- 20.5% of residents have incomes below the federal poverty line
- The median family has an annual income of **\$79,318**
